RESPONSE TO QUESTIONS ADDENDUM NO. 01

1. The RFQ file (PDF) is secured such that printing is disabled. Can you please provide an updated version that allows printing?

ANSWER: Yes, an invitation key has been sent for you to gain access via EBuilder.

2. RFQ Page 8: "Cover letter and table of contents is included in the thirty-five (35) page count, tabs are not counted." Please confirm that covers (front and back) are also not counted.

ANSWER: Covers front and back are not counted.

3. The listed roles on Page 45 use the description "Civil Structural Engineering Consulting and Design Services". Civil Engineering and Structural Engineering are two separate disciplines. Would it be acceptable to show one (1) Principal and one (1) Project Manager with experience overseeing and managing projects with both civil engineering and structural engineering components, and then listing an individual Civil Design Engineer, an individual Structural Design Engineering, and individual QA/QC engineers for each discipline?

ANSWER: The approach indicated is acceptable.

4. On page 8 in the fifth paragraph of RFQ No. AE- 176B it states that "A copy of the SOQ must be submitted in electronic format on a CD." Will a flash drive be acceptable for the electronic copy?

ANSWER: Yes, flash drive is acceptable.

5. Do the required Forms and Documents need to be submitted in a separate sealed envelope or are they included with the SOQ

ANSWER: Yes, the required Forms and Documents may be included with the SOQ.

- 6. Section 1.02 (pg. 7) states "The Professional Marine Engineering Consulting and Design Services will be procured in accordance with the Consultant's Competitive Negotiation Act (CCNA), adopted by the Florida Legislature in 1973, under Section 287.055, Florida Statutes, as amended, which requires state government agencies, municipalities or political subdivisions, school boards and school districts, to select a consulting firm based on qualifications rather than on a lowest bid basis."
 - a. Please clarify how JAXPORT interprets Section 287.055(2)(g) and how JPA intends to administer this contract. Specifically, will task orders be limited to those projects with an estimated construction value of less than \$2M or studies not exceeding a fee of \$200K?

ANSWER: Task orders will be issued in accordance with statute. However, Section 287.055(2)(g) also speaks to "work of a specified nature as outlined in the contract required by the agency.." The list of projects attached to the solicitation contains the projects of a specified nature and JAXPORT may proceed with utilizing the selected firm for these projects. However, the selection of a qualified firm does not create a vested interest in the projects listed nor is it a guaranty that JAXPORT will issue a task order for all such work. JAXPORT reserves the right to procure services for any or all phases of the work for projects on the list through an independent competitive process.

- 7. Section 3.0 (pg. 29) states "The Consultant Firm who has been selected to prepare the design criteria package is not eligible to render services under a Design-Build contract executed pursuant to the Design Criteria Package."
 - a. If the answer to the previous question is that task orders will be limited to the \$2M/\$200K threshold, please confirm that the Consultant Firm who has been selected to perform an alternatives study, conceptual engineering, or preliminary planning is eligible to render services under a traditional Design-Bid-Build contract executed pursuant to the work previously performed.

ANSWER: A consultant who conducts alternatives studies, conceptual engineering or preliminary planning of a project will be precluded from the project solicitation process regardless of the method of delivery or the project design fees / construction costs at issue.

- 8. Section 2.08 (pg. 14) states "No markup or profit shall be paid on non-labor related job costs, reimbursables or on services provided by subconsultants or others." Section 3.10.1.A.vii. (pg. 40) provides a framework for reimbursement of subconsultant administration costs.
 - a. Please clarify how JAXPORT intends to administer the contract with respect to subcontract administration costs, as these statements appear to be contradictory.

ANSWER: It is JAXPORT's intent to allow for an administrative mark-up rate as indicated in Section 3.10.1.A.vii as long as those costs are reasonable, allocable, and determined to be allowable under FAR – Part 31 Contract Cost Principles and Procedures, Sections 31.201, 31.202, 32.203 and 31.205.

- 9. SEB Requirements vs DBE Requirements (pg.18) Established 6% SEB participating goal. (pg. 70, Attachment F) DBE Utilization it states the DBE goal is 0%.
 - a. Can you please clarify the goal for this contract?

ANSWER: Projects included under RFQ _AE-176B will use a combination of funding from local, state and federal sources. Projects that will be strictly funded by local dollars will be assigned a six (6%) percent SEB (Small Emerging Business) requirement as detailed in the RFQ. JAXPORT supports FDOT's overall goals for DBE participation and encourages DBE subcontracting opportunities on projects funded through FDOT State funding; however, a DBE participation goal will not be assigned.
