RESPONSE TO QUESTIONS

1. Will there be a separate allowance line item for the permit fees (approx. \$65,000)?

ANSWER: Yes. The allowance will be \$70,000. See new Bid Form (Attachment No. 02)

2. What is the design mix specification for the 2" asphalt paving?

ANSWER: SP 12.5 Mixture per Section 234, FDOT <u>Standard Specifications For Road And Bridge</u> Construction July 2022.

3. Has there been a hazardous material survey performed on the facilities to determine if asbestos or other containments are present and in what quantities?

ANSWER: No. JAXPORT is not aware of the presence of any such materials. Contractor shall be responsible for conducting any surveys necessary to obtain demolition permits and to safely perform the work.

4. Who, how, and where are the utilities being handled and disconnected?

ANSWER: Contractor shall handle all termination and capping of utilities. Contractor shall coordinate with the JAXPORT Project Manager, the Blount Island operations staff, Mr. Barry Nelson, and JEA to actually have utilities shut off. All non-electrical utilities shall be capped or blank flanged at an appropriate location.

5. Will the successful contractor have access to water for dust control?

ANSWER: Yes.

6. Will the successful contractor have a minimum of 100' clearance around the entire facilities to perform demolition?

ANSWER: Yes.
