BACKGROUND:

This procurement is for the purchase of four (4) Hanjung crane roof assemblies. The four (4) Hanjung crane roof assemblies are being procured to replace 23 years old roof assemblies that are rusted and eroded due to salt air and direct sunlight. The existing crane roofs have been patched and painted numerous times and are now beyond repair and past their life expectancy. This roof replacement project will extend the useful life of the cranes by preventing water leaks from damaging the cranes' generators, engines and drive systems.
