#### REQUEST FOR PROPOSAL

### JPA CONTRACT NO.: C-1752R DESIGN-BUILD TERMINAL FACILITIES BUILDINGS (RE-BID) RESPONSE TO QUESTIONS

1. We are in receipt of the approval to submit a Price proposal for Project #T2021.07, Contract #C-1752R.

In order to provide an accurate estimate, two weeks is normally provided for quantity takeoffs, to collect estimates from subcontractors and to investigate and answer any questions that my arise during the process. Because of the week of the 23rd being a holiday week, many companies giving staff time off, making the estimating process even more difficult.

With this in mind, we are requesting two weeks in order to prepare an accurate estimate. We are requesting a price proposal date of Friday December 3rd. This allows a 2 week timeframe to prepare an estimate and takes into account the Thanksgiving weekend.
