Indemnity, RFQ Page 2-4, Paragraph 2.16 (a) and Attachment "F" Section 5.1.1 (a) Please confirm that the indemnity that the CMAR is to provide in the referenced portions of the documents are to be limited to the damages or claims "solely to the extent caused by the negligent acts or omissions of CM or entities working for the CMAR" and not broadly for claims "arising out of or incidental" to CMAR's negligent performance.

2. Page 1-6 of the RFQ, the last paragraph states minimum professional liability limits shall be \$2m per occurrence and in the aggregate however in attachments F and G the limit is \$5M. Please clarify.
