ADDENDUM NO. 02 RESPONSE TO QUESTIONS

1. Has asbestos & lead testing been performed? This is a requirement for permitting and OSHA regulations. If testing survey is not available, should bidder include cost for testing in the bid submission?

ANSWER: No, lead and asbestos testing has not been performed. If this is a requirement from any agency having jurisdiction, the Contractor shall include this testing.

2. The existing insulation is damaged in several areas. Is taping an acceptable method of repair? Please advise.

ANSWER: No, damaged insulation is to be removed. There is insulation in the roof system that will compensate for removed insulation.

3. The proposed construction time of 150 days, considering a 3-phased construction plan, is extremely aggressive and would require very large crews and overtime to achieve. A brief critical-path schedule for this project would be as follows: Perform roofing replacement = 2 months, 3 phases of siding replacement and painting at 2 months each = 6 months, Final punch-out/Close-out = 1 month. Total 9 months or 270 days. Would the Port Authority consider extending the time frame to make it more feasible?

ANSWER: This is a critical project for JAXPORT and the Tenant occupying this building. As such, the project construction time will remain as 150 calendar days from issuance of official construction NTP from JAXPORT. An Administrative NTP may be issued to allow the contractor to start working/providing submittals and to start ordering materials.

4. Has asbestos & lead testing been performed? This is a requirement for permitting and OSHA regulations. If testing survey is not available, should bidder include cost for testing in the bid submission?

ANSWER: No, lead and asbestos testing has not been performed. If this is a requirement from any agency having jurisdiction, the Contractor shall include this testing.

5. Will JAXPORT be providing a lift, ladder or means to get to the roof to do the work?

ANSWER: No. As stated in the Bid documents (see Scope of Work document), the Contractor is responsible to provide all equipment, labor and materials to complete this project.
