Escorting means Individuals without a TWIC may not enter restricted areas without having an individual who holds a TWIC as a side-by-side companion.

All visitors must be declared to security personnel and escorted. Any person not declaring passengers /visitors may be subject to arrest or trespassed from JAXPORT.

Individuals authorized by JAXPORT to escort a visitor must present a valid TWIC and JAXPORT TWIC Escort credential and have completed 33CFR105.215 and TWIC Escort training.

Escorts must possess the ability to immediately contact the JAXPORT Security Ops Center in the event he or she loses contact with the person(s) being escorted or if unlawful or Suspicious activity is suspected. **Call (904) 357-3360 24**/7 Escorted persons who fail to follow proper procedures for anyone conducting a TWIC escort may be subject to arrest or have their terminal access suspended or revoked.

Escorts must ensure that persons being escorted present a valid government identification with a photograph that meets 33 CFR 101.515 for entry into restricted access areas.

No more than 3 non-TWIC persons may be escorted at any one time in Restricted Access Area by a single escort.

An Escort for the purposes of TWIC Escorting is defined as continuous physical proximity to (i.e. side by side) and close visual contact with the escorted person(s).

Any person found in a Restricted Area without a TWIC badge or approved escort will be subject to arrest, suspension, and/or trespassed from the port. The incident will be treated as a security breach as defined in the JAXPORT FSP. Authorized TWIC Escort(s) along with the individual being escorted are responsible for abiding by ALL Facility Security Measures listed above.
